Vendors may not sell flea market type items or any other items not included in the Market Guidelines. Vendors are responsible for bringing their own tables, chairs, canopies and display items. It is recommended that you bring an umbrella or canopy for shade. Set up times are listed in the Farmers Market Guidelines.
